

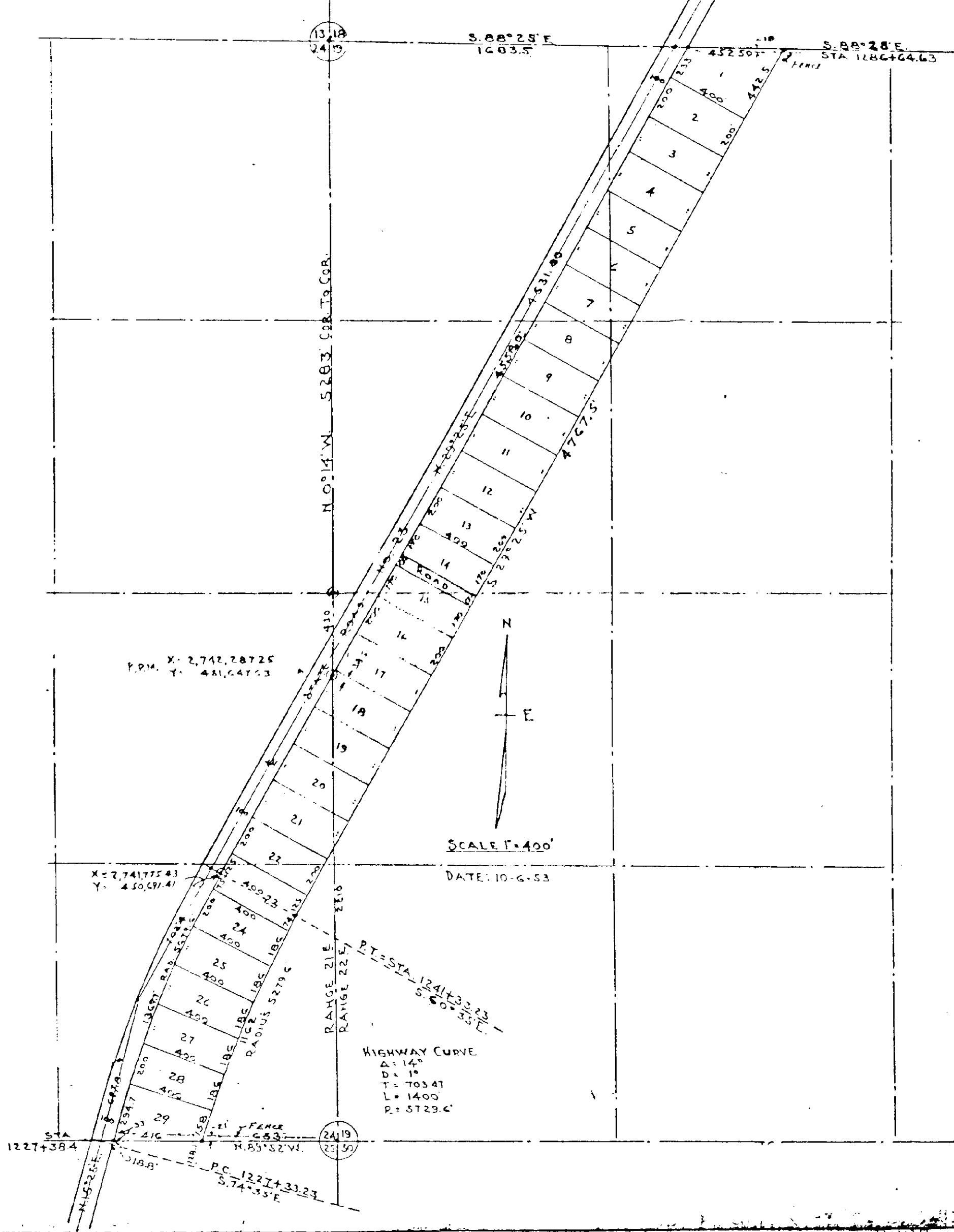

### GADSDEN HEIGHTS

A SUBDIVISION OF A PART OF THE NE 1/4 AND NW 1/4 OF THE SW 1/4 OF SECTION 19, TWS. 3-SOUTH, RANGE 22-EAST AND A PART OF THE E 1/2 OF THE SE 1/4 OF SECTION 24, TWS. 3-SOUTH, RANGE 21-EAST, BAKER COUNTY, FLORIDA.

#### DESCRIPTION

COMMENCE AT THE NW CORNER OF SECTION 19, TWS. 3-SOUTH, RANGE 22-EAST, BAKER COUNTY, FLORIDA AND RUN S. 88° 25' E. 1603.5 FT. TO THE EAST LINE OF THE 100 FOOT RIGHT OF WAY OF STATE ROAD NO. 23 FOR A POINT OF BEGINNING AND RUN THENCE 88° 25' E. ALONG SECTION LINE, 452.50 FEET, THENCE S. 29° 25' W. PARALLEL TO AND 400 FT. ON A PERPENDICULAR FROM SAID STATE ROAD RIGHT OF WAY, 4767.5 FEET, THENCE ALONG A CURVE DEFLECTING TO THE LEFT WITH A RADIUS OF 5279.4 FT., 1162.0 FT. TO THE SOUTH LINE OF SAID SECTION 19, THENCE WEST, ALONG SECTION LINE, 416.0 FT. TO SAID STATE ROAD RIGHT OF WAY, THENCE NORTHERLY, ALONG THE EAST LINE OF SAID RIGHT OF WAY, 5927.1 FEET TO POINT OF BEGINNING.
