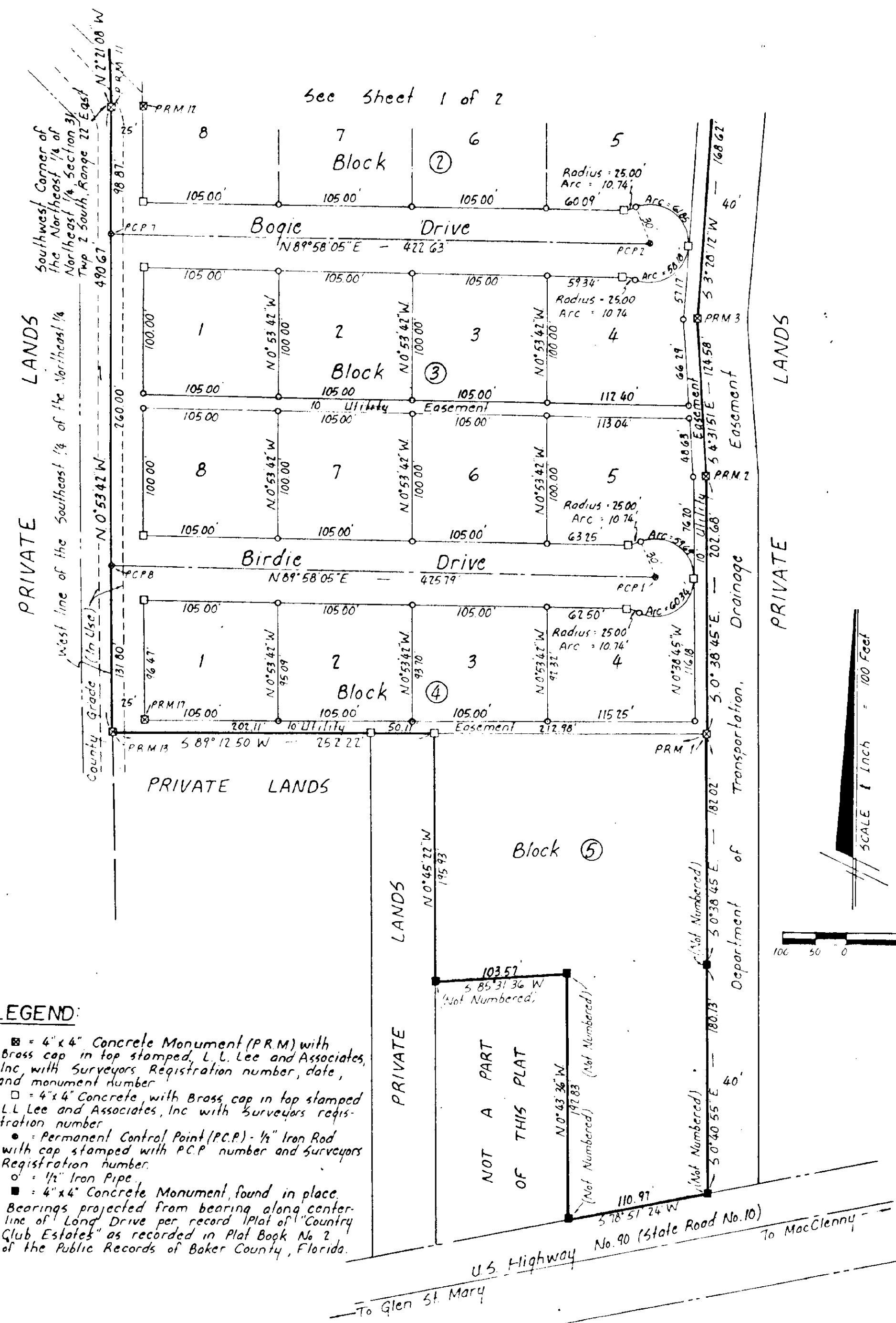


COUNTRY CLUB ESTATES "UNIT 2"
