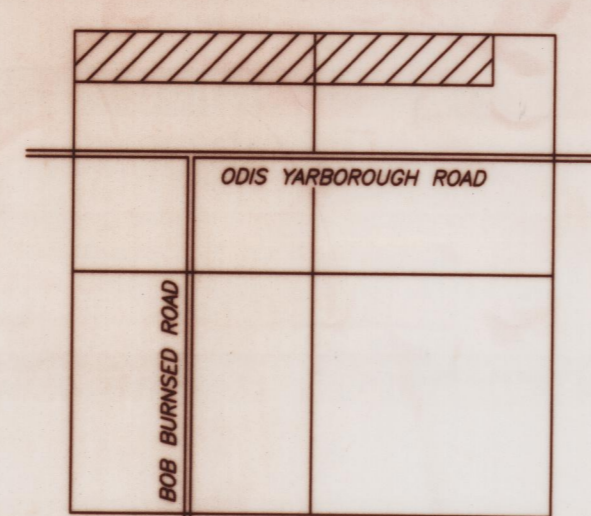


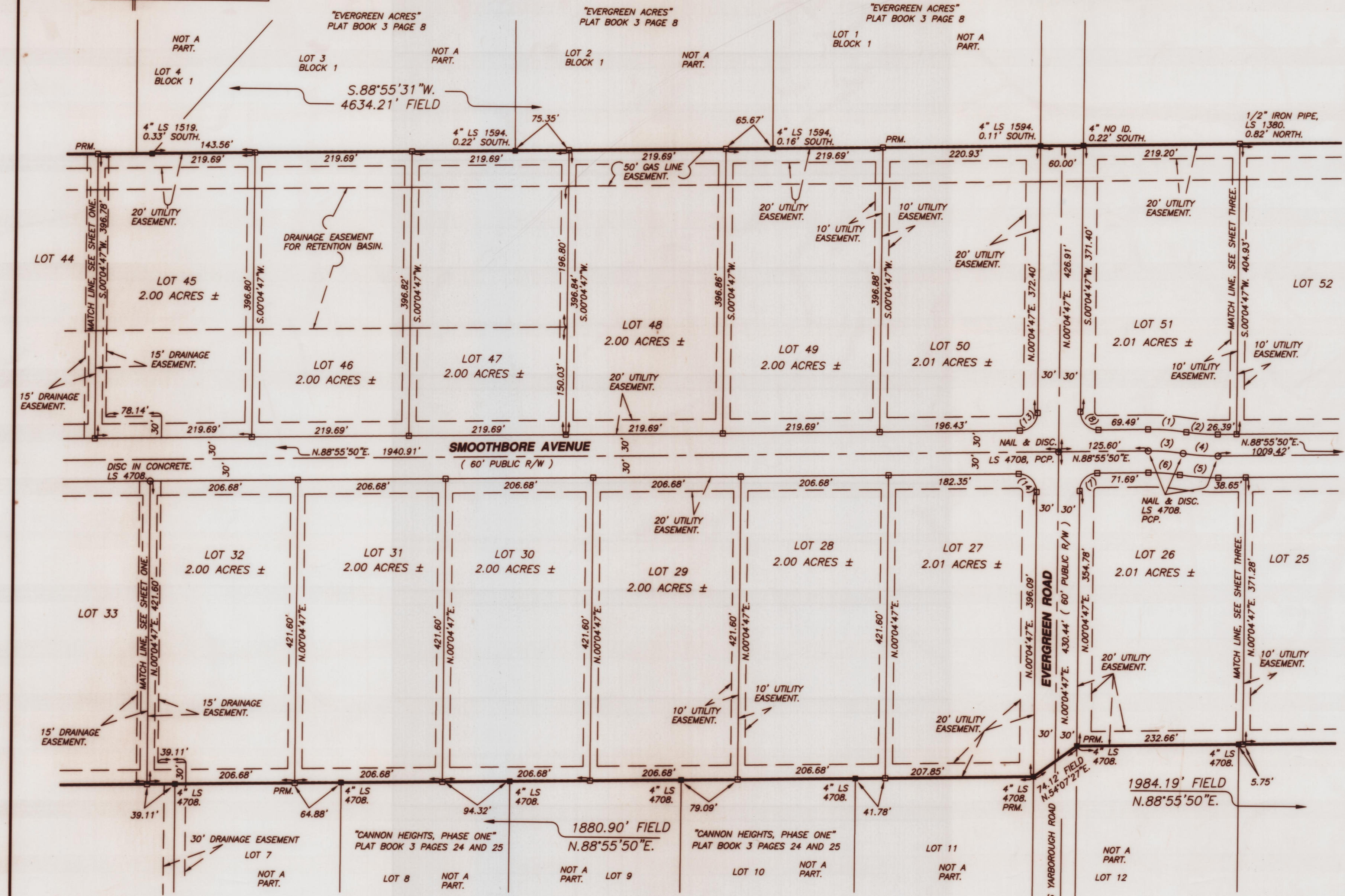

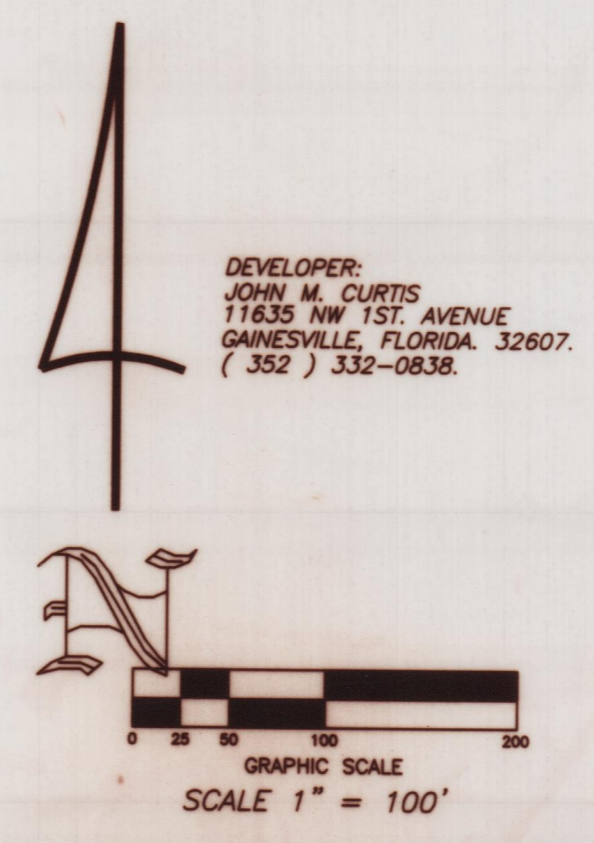


SECTION 12
