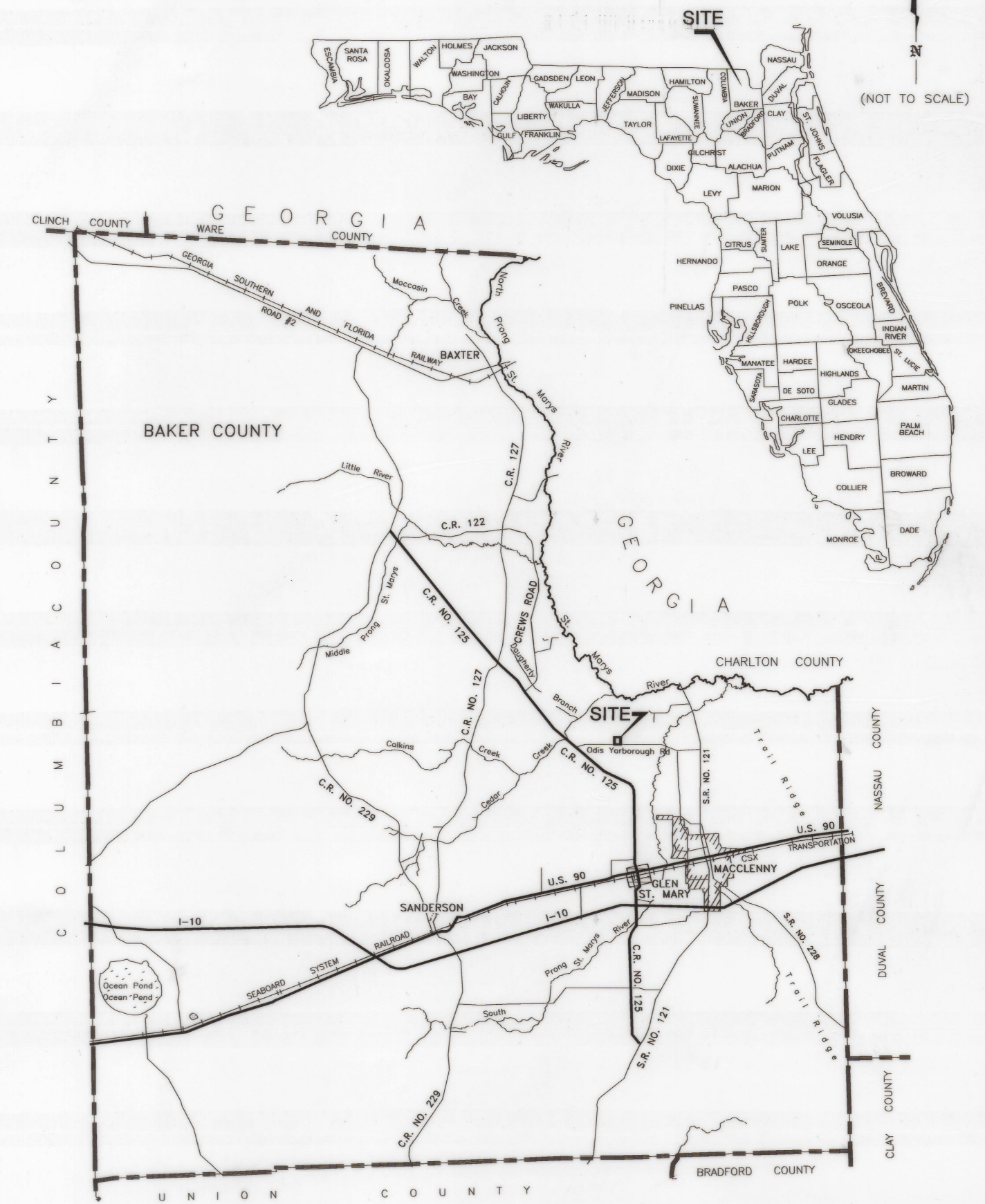


**"SHOALS PARK UNIT 2"**  
 BEING A PORTION OF  
 SECTION 11  
 TOWNSHIP 2 SOUTH, RANGE 21 EAST  
 BAKER COUNTY, FLORIDA



Description:  
 A parcel of land lying in Section 11, Township 2 South, Range 21 East, Baker County, Florida, being more particularly described as follows:  
 Commence at the Northwest corner of Shoals Park Subdivision, Plat Book 4, Pages 10-11, of the public records of Baker County, Florida; said point lying at the intersection of the North line of said Section 11 and the Easterly maintained right of way line of Fred Taylor Road, a county maintained Right of Way, thence N 88°57'45" W along the north line thereof, a distance of 40.51 feet to a point on the westerly maintained Right of Way of said Fred Taylor Road and the Point of Beginning; thence departing said North line, S 08°06'32" E along the Westerly maintained Right of Way line thereof, a distance of 429.73 feet; thence S 09°13'54" E along the Westerly maintained Right of Way line thereof, a distance of 919.16 feet to its intersection with the Northerly Right of Way line of Odis Yarborough Road (60 foot Right of Way as now established); thence S 89°49'46" W along the North right of way line thereof, a distance of 1348.01 feet; thence departing said North Right of Way line N 00°51'38" W, a distance of 1357.87 feet to a point on said North line of Section 11; thence S 88°57'45" E along the north line thereof, a distance of 1160.51 feet to the Point of Beginning.  
 Containing 38.00 acres, more or less.
